5. I understand that I am expected to carry 2020 tech/clutch inspection sheets at all events.
6. The BTPA strongly recommend safety neck braces to all drivers. I accept and understand that it is my choice whether I wear one.
7. I understand that my vehicle will undergo a safety inspection prior to pulling at any BTPA event, failure to pass this inspection may result in the vehicle being unable to compete.
8. I understand that The BTPA will not impose any ban or fine to tractors or members that pull at a non BTPA sanctioned event.
9. I accept and understand that the BTPA accepts no responsibility for its members or their machines when competing at non BTPA sanctioned events.
10. I accept and understand that no BTPA tractor is insured at a non BTPA sanctioned event, it is the responsibility of the puller to ensure adequate insurance is in place.
11. I agree that the above statement is intended to be as broad and inclusive as is permitted by the law, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full effect.

BTPA Statement of Release

I, the undersigned declare:

1. To release, waive, discharge and not to sue the BTPA/ETPC, including all its officials, all members of committees, its individual members, clubs, agencies of government and volunteer workers assisting in sanctioned BTPA/ETPC event activities, from all liability to me and my personal representatives, for all loss or damage, for bodily injury or death, or damage to property of the undersigned, which in any way grows out of, or results from any BTPA/ETPC event activity or part thereof.
2. To know, to be fully aware of, and to agree that the undersigned and/or his/her team drives at any BTPA/ETPC event completely for his/her own risk and his/her own account and to be fully responsible for that driving and for the therewith used materials and/or vehicles and that the undersigned and his/her team have a correct insurance regarding liability to third parties, while competing in, or being present at any BTPA/ETPC sanctioned event, with or without his/her vehicle. And that other vehicles beside the participating one also need to be fully insured.
3. To know the ETPC Rulebook and that the team and the used vehicles comply with that rulebook while taking part in any ETPC sanctioned event.
4. To know and to acknowledge that not complying with the ETPC Rulebook can and may cause danger or dangerous situations for competitions and/or other people and their properties.
5. To agree that the foregoing Statement of Release is intended to be as broad and inclusive as is permitted by the law, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
6. To have no objections to the publication of photographs or pictures or remarks made during the taking part in an BTPA/ETPC event.
7. To be familiar with the fact that all rights on all moving images and sounds, recorded during BTPA/ETPC events, are with the BTPA/ETPC. The recording of moving images or sounds during BTPA/ETPC events other than for personal use, like trade, sell or distribute is forbidden without explicit written permission of the BTPA/ETPC.
